

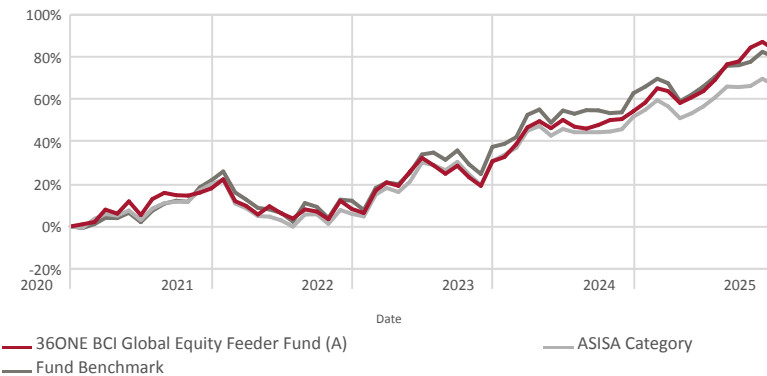
INVESTMENT OBJECTIVE

The 36ONE BCI Global Equity Feeder Fund's objective is to generate sustainable capital growth for investors by investing across mainly global equity markets.

INVESTMENT POLICY

The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the 36ONE Global Equity Fund PC, a sub-fund of SA Alpha PCC Limited, domiciled in Guernsey. The underlying portfolio invests primarily in global equity securities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

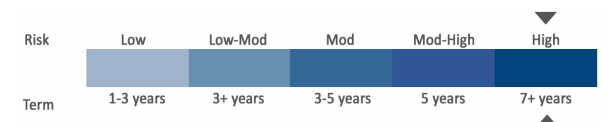

- The portfolio has a high exposure to derivative instruments, which may carry additional risks.

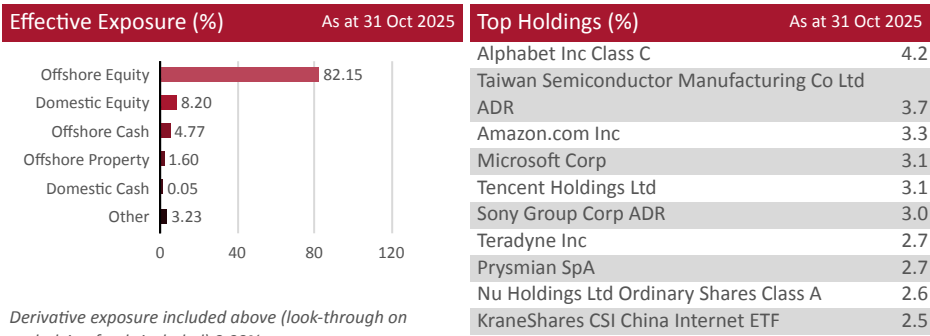
